

KKDIK Declaration Compliance

The EU REACH Regulation (EC) No 1907/2006 (Registration, Evaluation and Authorization of Chemicals) and KKDIK Regulation RG. -23.06.2017- 30105 (Registration, Evaluation, Authorization and Restriction of Chemicals) requires all substances imported into or manufactured in European and Turkey to be registered.

Polymer definition and classification

The definition of polymer in the KKDIK regulation is as follows;

hh) Polymer: Substances formed by consecutive monomer units of one or more types, distributed according to their molecular weight, and determined by molecular sequences in which the difference in molecular weight is primarily based on the difference in the number of monomers.

Polymers are not exempt from CLP regulation. If it meets the criteria to be classified as a polymer and has been placed on the market, it must be notified. Importing a polymer does not imply placing on the market monomers or other substances from which the polymer substance originates. C&L notification provisions regarding the import of a polymer can therefore only apply to the polymer substance itself.

Under REACH, substances used in articles are considered "polymers" when product safety data sheets and their contents are examined (ref. Title I, Article 3.5) and "polymers" are excluded from Title II - Registration and Title VI - Evaluation (ref. Title I, Article 2.9). is exempt.

According to the KKDIK regulation, polymers do not need to be registered. However, according to Article 7(3), monomers in the polymer and other chemicals not previously registered by an actor in the supply chain must be registered. In the KKDIK Regulation, monomer is defined in Article 4 (gg) and polymer is defined in Article 4 (hh). According to the annexes of this regulation, registration of components is not required. The provisions of the second and sixth parts of the KKDIK Regulation do not apply to polymers. The company has a registration obligation for monomers, auxiliary chemicals or additives that constitute polymers and are manufactured or imported in quantities of 1 ton or more per year. The company imports and exports ready-made polymers. It is exempt from registration.
